#### **Position Summary**

The position is a three-year full-time academic appointment beginning in August 2025 and is renewable upon mutual agreement. Responsibilities include teaching, research, scholarly activities, advising, field liaison and service.

We are seeking a talented educator and innovative scholar who is actively engaged in research, enthusiastic about teaching bachelor, master and PhD students. We are looking for a productive and cooperative colleague who will bring fresh perspectives to the theory,

research and practice of the subject.

### **Minimum Qualifications**

Applicants must have an earned **doctorate in Economics** from an internationally-recognized, accredited university. Applicants for this position should have at least 1-3 years of teaching experience in reputable universities and extensive professional experience in their major areas. ABDs will be considered if they meet the position qualifications and include in their application materials a letter from their dissertation chair confirming the defense date prior to the position's start date.
