# Bang College of Business, KIMEP University Accounting Faculty Position Description

The Bang College of Business invites applications for one Assistant/Associate Professor faculty position in **Accounting**. The Bang College of Business has been growing in enrollment and is therefore looking for new faculty member(s). Candidates are expected to teach various courses in Accounting for both undergraduate and graduate programs. The Bang College of Business offers Bachelor, Master, MBA and PhD programs. The Bang College of Business is the first EFMD program accredited school in Kazakhstan and Central Asia. We are currently working towards EQUIS and AACSB accreditation. The appointment will normally start in **Fall 2026** (August 15, 2026). Responsibilities involve teaching, research, and service.

#### Qualifications

Applicants must have an earned doctorate in **Accounting** from an AACSB/EQUIS accredited institution and/or working as a faculty in such accredited schools, and having demonstrated consistent and good quality of scholarship published in SSCI, ABDC/ABS and/Scopus Q1-Q2 ranked journals. Candidates who are recent graduates need to provide evidence about the potential to publish in the journals mentioned above. Candidates will be expected to publish one Scopus Q1-Q2 listed journal per year on average. The teaching load for this position will be 3 courses (9 hours) per semester. Further teaching reduction is

possible in case of track record of consistent high-quality publications. Teaching responsibilities will include undergraduate and graduate (MBA and PhD). Preference will be given to candidates who can also teach courses related to sustainability and ESG Reporting, artificial Intelligence and automation in Accounting, and digital/IT Auditing courses.

All classes are taught in English.
