Católica Porto Business School (CPBS) invites applications for a position of Associate/Assistant Professor level (depending on qualifications), to start September 1, 2023. Candidates should hold a Ph.D. in the scientific field (or related) and have significant international experience.

At the Assistant Professor level, we are looking for applicants with strong potential or track record of prestigious publications, and the ability to teach successfully at the undergraduate, MSc and executive education levels. At the Associate Professor level, candidates are expected to show a strong research track record in prestigious management journals, excellence in teaching, and the ability to add to the research reputation and productivity of the School. Compensation and teaching load are competitive with other prestigious European schools.

We are particularly, but not exclusively, interested in candidates with expert knowledge in the following topics:

- **Strategy:** sustainability, business strategy, corporate strategy, external growth options, and international management;
- **Accounting:** financial accounting; international accounting; auditing; public accounting; impact accounting; management accounting and control.
- **Finance:** corporate finance; capital markets; financial management; sustainable finance; banking; investment; valuation; risk management; corporate governance
- **Management Science and Information Systems:** supply chain management; business analytics; business intelligence.

- Research-based tenure requirements for Assistant Professor positions, to be assessed regularly during the contractual period.

The country is mostly known by its 850km of world-class sandy beaches, among the best weather in Europe, sports and culture, and is the 2nd best country for immigrants' integration in the world. Public transportation is good and there is a public healthcare system. Portuguese is usually listed as the 5th most spoken language in the world and the 3rd most spoken European language in terms of native speakers.

Porto is the second-largest city in Portugal, and one of the Iberian Peninsula's major urban areas. Located along the Douro River where it flows into the Atlantic, Porto has a rich history and culture, and its core was proclaimed a World Heritage Site by UNESCO in 1996. Home of the Port wine, Porto combines a small city's feel and friendliness with a vibrant and increasingly cosmopolitan atmosphere for the enjoyment of life's greatest things.

- Detailed academic and scientific curriculum vitae, in English;
- Scanned copy of the doctoral degree certificate;
- 2 reference letters (Optional);
- 1 current paper;
- 1 most significant publication;
- A teaching statement that describes your previous teaching experience (with evidence of teaching scores, where available) and future pedagogical development plans;
- A research statement that describes your previous research contributions and future research plans (Optional);

The applications, along with the documents mentioned above, must be delivered by the **3rd of March**. The absence of any documentation which cannot be internally obtained will result in the rejection of the application. Applications that do not meet the requirements or which are submitted after the deadline will also be rejected.

Selection Method

-

- Stage 1: Assessment of curriculum and other application documents;
- Stage 2: Interviews and research seminar for shortlisted candidates.

All candidates will be contacted after the shortlisting of applications is completed.
